## Guidance Notes for the Application for Admission to Participation in the Amateur Service and Recognition of Foreign Documents of Proof

Admission to participation in the amateur service (amateur radio admission) pursuant to section 3(1) of the Amateur Radio Act (AFuG) can only be granted upon submission to the Bundesnetzagentur of a signed application completed as required with all the relevant specified information and documents.

Applicants with legal representatives, such as **minors**, **must provide details of their legal representatives (parents/legal guardians)**. The application must be completed and signed by the applicant and by each legal representative. Please also give your current amateur radio call sign as well as at least one location for a planned amateur station in Germany in the space provided in the application form. Written queries relating to incomplete and/or incorrect applications cause delays in processing. Please therefore give a daytime telephone number in case of queries.

Equivalent documents of proof as referred to in **section B** of the application are, for instance, a former German amateur radio examination certificate or an invalidated German amateur radio admission or licence document - or a Harmonised Amateur Radio Examination Certificate (HAREC) in accordance with CEPT Recommendation T/R 61-02. **Applicants who have passed the relevant amateur radio examination of a country which has joined CEPT Recommendation T/R61-02 are therefore recommended to have a HAREC issued by the responsible foreign administration.** 

**Recognitions:** Upon presentation with the application of a foreign amateur radio licence - or a foreign amateur radio examination certificate <u>not</u> in conformity with CEPT Recommendation T/R 61-02 - i.e. also upon presentation of a foreign amateur radio novice examination certificate conforming to ERC Report 32 - the recognition and admission in the case of recognition under **section C** of the application must be requested.

In accordance with the scope of the Amateur Radio Act admissions pursuant to section 3(1) of the Act are granted only for the respective natural persons resident in Germany. Requests for preferred call signs can be made in the space provided in the application form. However, applicants do not have a right to a specific call sign.

The official acts in conjunction with this application are subject to non-recurring fee(s) as provided for by Annex 2 of the Amateur Radio Ordinance (AFuV) of 15 February 2005. Please see table below (extract from Annex 2 of the Ordinance):
